## EXECUTIVE ORDER IMPLEMENTING COVID-19 EMPLOYEE PROCEDURES

WHEREAS, on November 25, 2020, the Mayor of the Village of Bridgeview did issue a declaration of local state of emergency on account of the current threat of the spread of COVID-19; and,

WHEREAS, the Mayor deems it necessary and in the best interests of public health, safety and welfare to implement COVID-19 Employee Procedures.

NOW, THEREFORE, IT IS HEREBY ORDERED by the Mayor of the Village of Bridgeview, Cook County, State of Illinois, as follows:

Section 1. COVID-19 Employment Procedures Adopted. That the Village of Bridgeview Revised COVID-19 Employee Procedures dated November 24, 2020, being otherwise incorporated by reference as though fully set forth herein, are hereby adopted and shall take immediate effect for all employees and officials of the Village of Bridgeview.

Section 2. Effective Date. This order shall be effective upon its execution and shall continue in full force and effect until there no longer exists a local state of emergency in effect for the Village of Bridgeview.

### DECLARATION OF LOCAL STATE OF EMERGENCY

I, Steven M. Landek, Mayor of the Village of Bridgeview, being first duly sworn upon oath, do hereby declare that a Local State of Civil exists in the Village of Bridgeview, County of Cook, State of Illinois, as of this November 25, 2020 at 2 P.M., due to the COVID-19 outbreak, the spread of which threatens injury to persons such that extraordinary measures must be taken to protect the public health, safety and welfare. This declaration is made pursuant to and in accordance with the provisions of Section 11-1-6 of the Illinois Municipal Code (65 ILCS 5/11-1-6), Section 11 of the Illinois Emergency Management Agency Act (20 ILCS 3305/11), and Chapter 1, Government Organization, Article 9, Civil Emergencies, of the Municipal Code of Bridgeview.
