

VILLAGE OF BRIDGEVIEW
PERSONNEL BOARD MINUTES
SEPTEMBER 26, 2022 MEETING
6:00PM
MAYOR'S CONFERENCE AREA

Chairman Lewis called the September 26, 2022 meeting of the Personnel Board to order at 6:00pm.

Roll Call indicated that Members Ahmad, Mazarka, Gholeh, Regep and Chairman Lewis were present. There was a quorum. Also present were Attorney Zarzour and Secretary to the Personnel Board, Cathy Siciliano.

Chairman Lewis looked for a motion to approve the minutes of the regular meeting held on August 29, 2022. Motion was made by Member Ahmad and seconded by Member Regep. Roll call vote:

AYES: Members Ahmad, Mazarka, Gholeh, Regep and Chairman Lewis.

NAYS: None.

There being five ayes and no nays, the MOTION CARRIED.

Chairman Lewis looked for a motion to go into closed session for matters of personnel and review of closed session minutes. Motion was made by Member Gholeh and seconded by Member Ahmad. Roll call vote:

AYES: Members Ahmad, Mazarka, Regep, Gholeh and Chairman Lewis.

NAYS: None.

There being five ayes and no nays, the MOTION CARRIED.

The Personnel Board went into closed session at 6:02pm.

The Personnel Board went back into open session at 6:03pm.

Chairman Lewis looked for a motion to approve the closed session minutes from the August 29, 2022 meeting. Motion was made by Member Regep and seconded by Member Ahmad. Roll call vote:

AYES: Members Ahmad, Mazarka, Gholeh, Regep, and Chairman Lewis.

NAYS: None.

There being five ayes and no nays, the MOTION CARRIED.

Chairman Lewis asked if there were any bills to be paid to which Secretary Siciliano stated that there were none but when bills come in that were not approved during an open session of this Board, they will be given to Chairman Lewis to sign.

Secretary Siciliano stated that item "4d" of the agenda referenced to the results of the written Entry Level Police Officer. Chairman Lewis stated that "we" decided to extend the deadline in the process. After Chairman Lewis stated that he notified this Board of this decision, Secretary Siciliano expressed her thanks to all for not notifying her of the decision even though she is as important to this Board as are any of them. She also wanted to know if this extension was private and only for certain people as the notification was not in the newspaper nor on The Blue Line. In the discussion, it was brought up that it was on the home page of the village's website to which Secretary Siciliano stated that the extended date for the Entry Level Police Officer on this home page listed the wrong date.

Attorney Zarzour stated that the notice will be on the Blue Line either this evening or by tomorrow morning. He further stated that it would not be put into the newspaper. Chairman Lewis stated that he didn't believe that there were enough people who read/get the newspaper. Chairman Lewis stated to the attorney to have the village's home page be corrected with the info and that this info would inform those seeking to file an application through Stanard and Associates. Secretary Siciliano questioned how many persons outside of Bridgeview and even those who reside in this village actually read the home page. Secretary Siciliano continued stating that this info should have been made public so any person interested would have been able to have seen this extension. She also asked who puts this info on The Blue Line and in the newspaper to which the attorney and the chairman responded, "We do."

Chairman Lewis looked for a motion to adjourn. Motion was made by Member Gholeh and seconded by Member Regep. By voice vote, the MOTION CARRIED.

The meeting adjourned at 6:12pm.
