NOVEMBER 1, 2022

MAYOR'S CONFERENCE AREA
(CALLED BY CHAIRMAN LEWIS AT THE SPECIAL MEETING OF OCTOBER 18, 2022)

Chairman Lewis called the November 1, 2022 special meeting of the Personnel Board to order at 6:00pm.

Roll Call indicated that Members Regep, Ahmad, Mazarka, Gholeh and Chairman Lewis were present. There was a quorum. Also present were Attorney Zarzour and Secretary to the Personnel Board, Cathy Siciliano.

Chairman Lewis looked for a motion to approve the minutes for the special meeting held on October 18, 2022. Motion was made by Member Regep and seconded by Member Mazarka.

Roll call vote:

NAYS: None.

There being five ayes and no nays, the MOTION CARRIED.

Chairman Lewis mentioned that those on the list wanting to become Lieutenants will have the assessment portion on Saturday at 9:00am at the Community Center.

Chairman Lewis looked for a motion to go into closed session for matters of personnel and interviews. Motion was made by Member Regep and seconded by Member Ahmad. Roll call vote:

The Personnel Board went to closed session at 6:08pm.

The Personnel Board came back to open session at 7:20pm.

Chairman Lewis looked for a motion to approve the closed session minutes from October 1, 2022. Motion was made by Member Ahmad and seconded by Member Regep. Roll call vote:

There being five ayes and no nays, the MOTION CARRIED.

Chairman Lewis stated there would be a list of Firefighters Lieutenants by next week.

Chairman Lewis brought up three bills that need to be paid and looked for a motion to pay \$1,843.85 to Stanard & Associates for Police Officer hiring process; \$1,961.85 for Firefighters hiring process; and \$14,394.00 for Assessment and Testing of the Firefighter candidates.

Motion was made by Member Ahmad and seconded by Member Regep to pay all three bills.

Roll call vote:

AYES: Members Regep, Ahmad, Mazarka, Gholeh and Chairman Lewis.

NAYS: None.

There being five ayes and no nays, the MOTION CARRIED.

Chairman Lewis looked for a motion to adjourn. Motion was made by Member Gholeh and seconded by Member Mazarka. By voice vote, the MOTION CARRIED.

The meeting adjourned at 7:24pm.
