## Permit Application

To be completed by the retailer:

- I. The application for the permit for consumer distributors and retailers sale of fireworks shall be made to the Fire Chief a minimum of fourteen (14) days prior to commencing sales.
- II. Prior to processing the application, the Fire Chief shall determine that the proposed location is compliant with all applicable fire and life safety codes.
- III. The application shall include the following required information:
  - 1. A letter from the person legally responsible for the property on which the State of Illinois regulated consumer grade fireworks sales will occur. Such a letter shall grant permission to the applicant for the use of the said property.
  - 2. Proof of Certificate of Liability Insurance for public general liability, bodily injury and property damage from a recognized insurance carrier approved by the Village of Bridgeview in the minimum amount of one million (\$1,000,000) for each occurrence.
  - 3. A legible floor plan designating the area for storage for retail sales display along with fire extinguisher locations. \*\* Note, fire extinguishers shall be within 30 feet from the display area.

- 4. A detailed Packing List consisting of the total weight, novelty name(s), case amount(s), quantity and description of each item for retail sale. All novelties shall be in compliance under the Illinois Pyrotechnic Use Act 425 ICLS35/1. Also required are the applicable Safety Data Sheets (SDS) for each item.
- 5. The firework Consumer Distributor shall provide proof of licensure from the State of Illinois Office of State Fire Marshall (OSFM) and must be registered herein and verified by the Pyro/Safety Inspector.
- IV. The firework Consumer Distributor will pick-up all items that are not sold within seven (7) to ten (10) days after the promotion.
- V. Any permit granted hereunder shall be non-transferable.
