Chairman Regep called the July 22, 2024 meeting of the Personnel Board to order at 6:38pm.

Roll Call indicated that Members Pullum, Lopez, Mazarka, and Chairman Regep were present. Absent was Member Gholeh. **There was a quorum.** Also present were Attorney Zarzour and Secretary to the Personnel Board, Cathy Siciliano.

Chairman Regep asked for the approval of the minutes of June 24, 2024. Motion was made by Member Mazarka and seconded by Member Pullum. A discussion followed with a request to amend the minutes of June 24, 2024. Member Mazarka agreed to the motion to approve the minutes of June 25, 2024 as amended. Roll call vote:

There being four ayes, no nays and one absent, the **MOTION CARRIED.**
